VII. TRUST PURPOSE

The Trust may acquire real and personal property, enter into contracts, and engage in other activities which are customary to Trusts, for the purpose of making its assets available for the use of certain Beneficiary(s) that they may better facilitate the advancement of the Christian religion by teaching, preaching, worshipping, ministering, evangelizing, publishing, propagating the gospel of Jesus Christ, Christian fellowship, engaging in charity and acts of benevolence, and otherwise fulfilling the obligations of the Body of the Lord Jesus Christ as specified in the Word of God, the Holy Bible. The nature of the activities facilitated by this Trust are religious, sacerdotal, educational, eleemosynary, benevolent and charitable. The Trust shall repose in the Trustee(s) fiduciary responsibility and absolute control of certain property, assets, and funds (hereinafter called "Trust corpus"), now or hereafter held by or contributed to, donated to, paid to, transferred, exchanged, or otherwise conveyed to them and their successors as Trustee(s), for their protection, conservation, and increase, for the beneficial use of the Beneficiary(s). The Trustee(s), acting in their fiduciary capacity, shall carry out their duties, subject to the terms and conditions of the Declaration of Trust & Trust Indenture (hereinafter called "Trust instrument").

VIII. DECLARATION OF NON-TAXABLE STATUS

In accordance with the Trust's objective to conserve the Trust's corpus for the exclusive use of religious purposes, this Trust shall be non-taxable and not liable for any income tax, capital gain tax, property tax, estate tax, gift tax, or otherwise, pursuant to the First Amendment of the Constitution for the United States of America, and as affirmed in the Internal Revenue Code \$508(c)(1)(A), and IRS Publications 557 and 526. The foregoing may not necessarily limit any tax liability of the Trust, when it engages in activities in jurisdictions outside the United States. However, the Trustee(s) shall use their discretion to avoid taxes, whenever and wherever possible, and may seek the advice of competent tax counsel.

IX. TRUST IRREVOCABLE - NO RETAINED CREATOR POWERS

The Creator declares that this Trust shall be irrevocable and that the Creator shall be without power to alter, amend, revoke or terminate any of the provisions of the Trust instrument. The Creator reserves no domination or control over the principal or earnings of the Trust corpus, or the designation of any Beneficiary or Trustee, herein. The execution of this instrument by the Creator specifically warrants the above declaration.

X. BENEFICIARY(S) OF THE TRUST:

The Beneficiary(s) of this Trust are those certain persons, group of persons, churches, ministries, or religious purposes identified in the records maintained by the Trustee.

XI. BENEFICIARY RIGHTS AND POWERS:

The beneficial interest of any Beneficiary to this Trust shall consist solely of the privilege of sharing in the beneficial use of certain Trust assets as authorized at the discretion of the Board Of Trustees. No Beneficiary to this Trust may exercise any control whatsoever in any matters of the Trust or any Trustee or Trust Officer.
